AN ORDINANCE TO AMEND SECTION 6, ORDINANCE NO. 3-27-1969 (70), ENTITLED "AN ORDINANCE ESTABLISHING A PARKING VIOLATIONS BUREAU FOR THE VILLAGE OF NASHVILLE "

THE VILLAGE OF NASHVILLE ORDAINS:

SECTION 1. Amendment of Section 6, Ordinance No.3-27-1969 (70). That Section 6, Ordinance No.3-27-1969 (70) is amended to read in its entirety as follows:
